Dearest PIO's and support staff,

I'd like to request records from the Clark County Coroner's office / Medical Examiner's Office.

The specific records requested are:

"All notes, photographs, drawings, amendments, video, audio, and security footage pertaining to the autopsy of the body recovered from room 32-135 of the Mandalay Bay on 1 Oct 2017, tentatively identified as Stephen Paddock. Additionally, a request is made for the fingerprint identification methods employed by investigators, and chain of custody records for those fingerprints associated with the body tentatively identified as Stephen Paddock. A request is also made for the radiographs of the body, the name of the radiographer who took X-rays of the body, and any additional students, witnesses, forensic scientists, or other personnel who came in contact with the body but were not mentioned in the official autopsy report. Finally, a request is made for any notes, documentation, orders, or decisions related to the action of cremating the decedent's body."

The recently released LVMPD FIT Report states that photographs and radiographs were taken during the autopsy of the body alleged to be Stephen Paddock, as would be customary in pathological sciences.

Please advise as to the expected timeliness and associated fees of this request.
